

Camping Rules

- Cooking and lighting mosquito coils are not allowed inside the tent(s). HK\$500 will be charged as cleaning fee.
- Please note that the quiet time starts at 10pm, please consider other users and do not affect them.
- Smoking are not allowed inside the tent(s), HK\$500 will be charged as cleaning fee.
- If guests bring their own cook set and camp stove into our campground/main building, it will charged HK\$500.
- No mosquito coils are allowed to light inside the tent(s).
- Restricted Items: Candles (unless served in aseepage-proofed container), incense, fireworks (except bonfire at pre-assigned fire pit), open flame, and weapons.
- No running or jumping on the camping mattress.
- Please keep the tent(s) clean, garbage should throw into the garbage bin before leaving.
- To be environmental friendly, please switch off all the electronic appliances before you leave.
- Please return the air conditioner remote to our reception counter when checking out. HK\$500 will be charge if it lost.
- Charcoal must be placed in the barbeque grill that provided by us to avoid charcoal burning elsewhere.
- Pet owners please note that, as we have to consider other guests as well, please leashed and muzzled them if needed.
- Pets are not allowed to stay inside the tent(s), they can sleep outside the tent and should be well-behaved and do not dig holes at our grassland.
- Owner should be responsible to their pets and not allow your dog to foul in our campsite or mainbuilding.
- If damages are found in our property and facilities, guests must compensate according to the price.

The Clients are liable for damages to the Centre caused by an act or an omission of Clients. These include, but not limited to missing or damaged furniture, fixture, watersport gears, camping facilities, equipment, decorations, lawn, plants, trees, or fencing.
